- a) The sign is a 3' x 5' double-sided aluminum sign
- b) The sign will be placed 4 ft. from edge of sidewalk to the post
- c) There is 3' from bottom of sign to grade
- d) The sign reads:

- e) Colors are dark green with gold lettering

There will not be any lighting on the sign. The size and placement is okay as submitted.

2) Grande's One Genny Pizzeria and Restaurant – 1 Genesee Street, sign application

Mr. Grande and Mr. Inman were present with all necessary information for three signs at 1 Genesee Street.

The signs are as follows:

- There will be a 4' x 3' sign on the north side of the building (small parking lot on left side). The sign will have one gooseneck light over it.
It will read: One Genny
 Pizzeria and Restaurant
 Parking in Rear
- There will be a 72" x 30" sign on the rear of the building. The sign will have two gooseneck lights over it.
It will read: One Genny
 Pizzeria and Restaurant
- There will be a 30" wide x 24" tall sign on the front of the building to the right side of the front door. There will be soft white lighting in the existing black canopy that is there. The sign will read the same as the 4' x 3' sign above.

The colors of the signs are black with copper/gold lettering.

The frontage of the building is 95 feet which meets the requirements of the signage for the building.

It is going to be a Restaurant, Sports Bar and Pizza take out. They hope to be open by the end of September.

The front of the building has large black doors. The left side of the building will be sided also to match the rest of the building.

Upon motion by Barbara Goodman, seconded by Richard Fountain, the Planning Board recommended approval of the signs as submitted. All voted in favor.
